Scale of Fees for Plot Reservations, Burials and Monuments and Searches.

**NOTES**

- (a) "Resident" means residing within the boundary of the Local Government Parish Area of Wythall, (as opposed to the Ecclesiastical Parish Area). Should a resident have to leave Wythall to receive care, upon their demise, they would still qualify as a "resident" and be entitled to be buried in Wythall but proof of previous residency would be required.
- (b) Plots may be reserved by residents at the appropriate fee prevailing at the time, but the plot must only be used in respect of the person/persons recorded on the Cemetery Register of Reservations.
- (c) The fee payable includes the right to erect a monument of approved dimensions on the slab provided. A monument may be erected immediately after an interment. No further charges will be made by the Parish Council for any additional inscription work.
- (d) No further fee shall be payable for a burial, in the case where the plot reservation has been previously made and paid for.
- (e) Where a further burial takes place in a grave or plot where a fee has already been paid for a first burial, a re-opening fee only shall be paid.
- (f) The fees include the issue by Wythall Parish Council of a formal written **70 year Grant of Right of Burial**.
- (g) The fees include the future maintenance of the Cemetery as a "lawn Cemetery" by the Parish Council, **but do not include the cost of funerals or the fees of undertakers, grave diggers and monumental masons** for which the Parish Council will not accept any responsibility for payment.
- (h) Rules governing the administration of the Cemetery are available for inspection at the Offices of Wythall Parish Council and must be strictly observed.
- (i) This Scale of Fees will be reviewed annually. Any change will take immediate effect and supersede all previous Charges.
