Road Traffic Regulation Act 1984 (As Amended)

Worcestershire County Council (Bromsgrove District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2018 [Prohibition of Waiting, Restriction of Waiting and Limited Waiting on Beaudesert Road, Shawhurst Croft and Shawhurst Lane, Hollywood, Wythall] and (Shawhurst Lane, Hollywood, Wythall) (No Stopping on School Keep Clear Markings) Order 2018

On **20 December 2018** Worcestershire County Council made an Order the effect of which will be to **prohibit waiting at any time** on the following lengths and sides of road in **Hollywood, Wythall:-**

Beaudesert Road (north side) from a point 14.5 metres west of its junction with Shawhurst Lane for a distance of 26.1 metres in a westerly direction.

Shawhurst Croft (west side) from a point 40.9 metres north of its junction with May Lane for a distance of 36.9 metres in a northerly then westerly direction.

Shawhurst Lane (west side) from a point 16.3 metres south of its junction with May Lane for a distance of 32.4 metres in a southerly direction; from a point 100.4 metres south of its junction with May Lane to a point 8.4 metres north of its junction with Beaudesert Road. **Restrict Waiting Monday – Friday 8.00am – 5.30pm Shawhurst Croft (east side)** from a point 10 metres north of its junction with May Lane for a distance of 63.4 metres in a northerly direction. **Limited Waiting 1 hour no return within 2 hours Monday – Friday 9.30am – 2.30pm and restriction of waiting Monday – Friday 8.00am – 9.30am and 2.30pm – 4.30pm Shawhurst Lane (east side)** from a point 32 metres north of its junction with Beaudesert Road for a distance of 30 metres in a northerly direction.

The Order will vary the above Consolidation Order (which provides for civil enforcement of contraventions of waiting prohibitions and restrictions) and will contain exemptions to allow parking/access for certain purposes and limited waiting by disabled persons' vehicles.

Worcestershire County Council have made an Order the effect of which will be **No stopping on School Keep Clear Markings Monday – Friday 8.00am to 5.30pm Shawhurst Lane (east side)** from a point 45.3 metres south of its junction with Beaudesert Road for a distance of 45 metres in a southerly direction; from a point 24.5 metres south of its junction with Beaudesert Road for a distance of 39.8 metres in a northerly direction; from a point 62 metres north of its junction with Beaudesert Road for a distance of 34.4 metres in a northerly direction.

The Order will come into operation on **10 January 2019**

A copy of the Order, relevant map and Statement of Reasons for making the Order may be inspected at Bromsgrove District Council, Customer Service Centre, Parkside, Market Street, Bromsgrove B61 8DA, and County Hall, Spetchley Road, Worcester, WR5 2NP during normal office hours.

The validity of the Council's powers in making the Order or this exercise of them may be questioned by application to the High Court within 6 weeks from the date on which the Order was made.
