Road Traffic Regulation Act 1984 (As Amended)
Worcestershire County Council (Bromsgrove District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2019 [Prohibition of Waiting and Restriction of Waiting on Fords Road and Rosebriars, Wythall]

Worcestershire County Council are to consider making an Order the effect of which will be to prohibit waiting at any time on the following lengths and sides of roads in Wythall:

Fords Road (both sides) from its junction with Haslucks Green Road for a distance of 12.5 metres in a northerly direction. **Rosebriars (both sides)** from its junction with Haslucks Green Road for a distance of 9 metres in a northerly direction.

Restrict Waiting Monday – Friday 12.00 noon – 1.00 pm:-

Fords Road (west side) from a point 12.5 metres north of its junction with Haslucks Green Road for its entirety to a point 12.5 metres north of the junction on the east side. **Rosebriars (west side)** from a point 9 metres north of its junction with Haslucks Green Road for its entirety to a point 9 metres north of the junction on the east side.

The Order will vary the above Consolidation Order (which provides for civil enforcement of contraventions of waiting prohibitions and restrictions) and will contain exemptions to allow parking/access for certain purposes and limited waiting by disabled persons' vehicles.

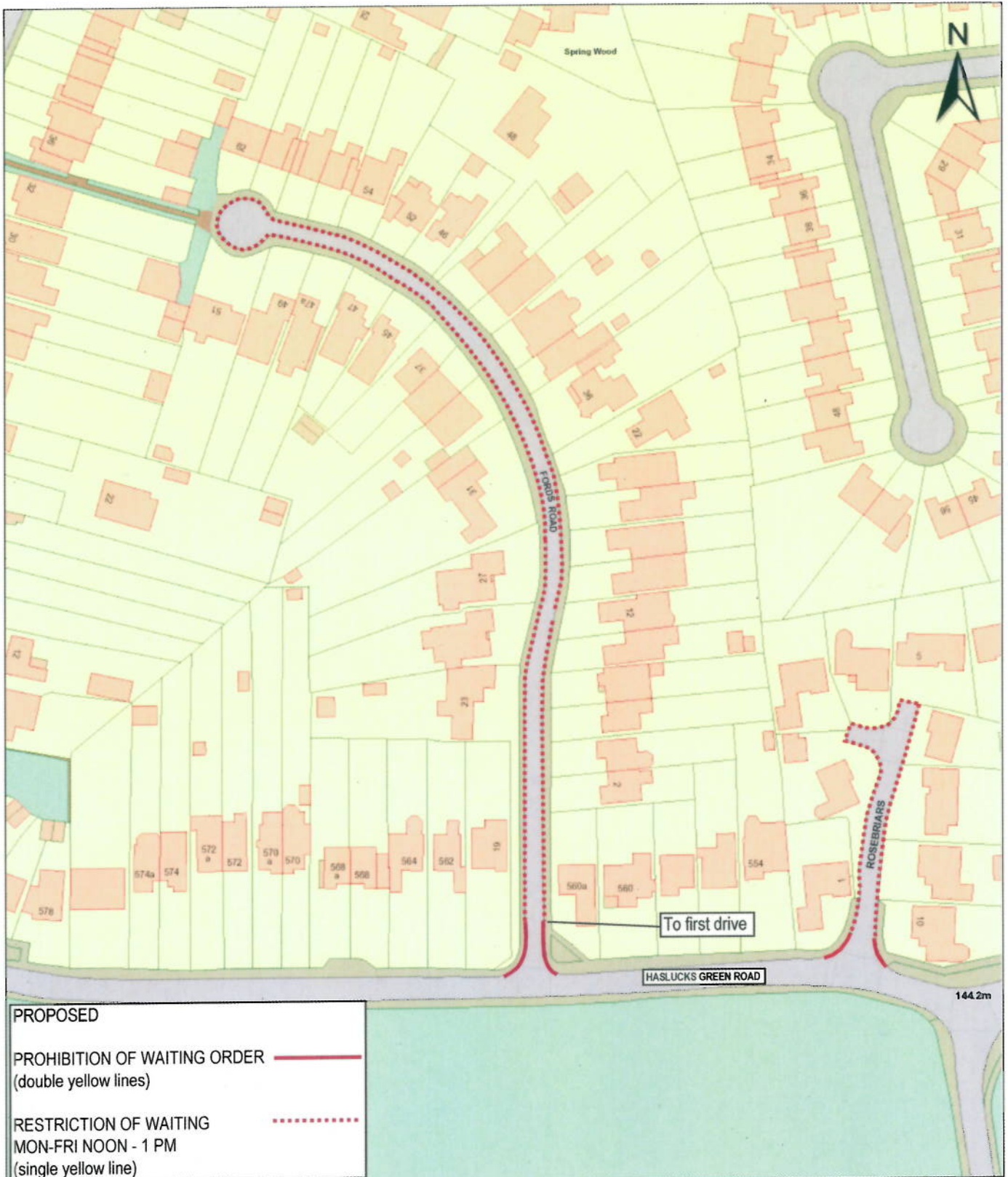
Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Bromsgrove District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the roads and sides of roads identified in the plan attached to this Order a prohibition of waiting and restriction of waiting Monday – Friday 12.00 Noon – 1.00 pm in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on XXXX 2019 and may be cited as Worcestershire County Council (Bromsgrove District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2019 [Prohibition of Waiting and Restriction of Waiting on Fords Road and Rosebriars, Wythall].
